## B. Loyalty Day - Parade Route & Road Closure

**MOVED** by Rang and supported by Fleszar to approve the parade route and closure of Cedar St from Airpark Dr. to Cass St. including the red light

## C. Hodgins Asphalt - Road Proposal

- 1<sup>ST</sup> Bid N Grove St to Cedar St.— Due to county project starting in April and projected to run through the summer this portion of the project will need to be postponed till 2024.
- 2<sup>nd</sup> Bid Cass St to Cedar St. two options were presented by Hodgins.
  - o Mill Full Depth of Road and Repair
  - Re-Surface current road City Manager recements this option, due to the amount of traffic this road sees daily and the longevity a re-surfacing would offer -\$77,200.00.
- 3<sup>rd</sup> Bid Elm St Remove existing asphalt and repair base \$9,865.00.
- The City Manager is going to consider other roads within the City Limits that need attention, due to needing to postpone the work on N. Grove St.

**MOVED** by Rang and supported by Link to move forward with Bid 2 for \$77,200.000 and Bid 3 for \$9,865.00.

# D. Airpark Plastics – Dockett # 21-003889, Joint Stipulation

• Due to a clerical error on Airpark Plastic's tax assessment, they were forced to pay an assessment that was to high. Due to a timeliness issue, the only resolution it through the Michigan Tax Tribunal. The City of Standish is in agreement that there was errors, but are in agreement to attempt through the Tribunal to correct the error. The decision made

by the Tribunal may result in the assessment not being changed in the year in question due to the timeliness of the filing by the claimant.

**MOVED** by Rang and supported by Fleszar to sign the joint stipulation paperwork for Airpark Plastics, so that it can be presented at the State Tribunal.
