A. Public Hearing – 2024/2025 Budget First Reading

• The City Manager presented a draft of his proposed budget to the City Council.

B. Public Hearing – Easement Abandonment – Airport Drive/County Fairgrounds Property

MOVED by Link and supported by Rang to go into a Public Hearing for Easement abandonment of Airport Drive running through the County Fairgrounds Property at 6:15pm.

All approved, motion carried.

- Airport Drive is plotted to run through the County Fairgrounds property to S. Limits Rd
- The County has asked if the city will abandon this easement so that they might move forward with their fairground's renovation project.
- This abandonment would not affect the established Airport Drive that runs along the front side of the fairgrounds.

C. Public Hearing – Park Lane Road Closure / Abandonment, Resolution 24-01

MOVED by Link and supported by Rang to go into a Public Hearing for Resolution 24.01 abandonment/closure of Park Lane Road 6:20pm.

• When Park Lane Road was established, it was not given a proper base or drainage, causing large pools of water to sit in low places and gravel to be absorbed down into the ground.

- o The city is not able to properly maintain this road as needed.
- Fire department/Police have no use for this road but request a key to the gate if the road is closed by the city.
- The City Manager proposed putting a gate at the end of Washington Dr., making it a dead-end road once again.

MOVED by Rang and supported by Link to Leave Public Hearing for Resolution 24.01 abandonment/closure of Park Lane Road 6:22pm.

MOVED by Rang and supported by Fleszar to adopt Resolution 24.01 Abandoning/closing Park Lane Road at the end of Washington Rd.

9. **NEW BUSINESS**

A. Aeration Pump & Check Valve

- The Aeration Pump & Check Valve both need to be replaced.
 - o The Check Valve is located at the Water Treatment Plant
 - The estimated cost to replace this is \$7,500 and will take approximately 30 days to receive after the order is placed.
 - Aeration Pump is for the sewage ponds to pump air into the ponds to keep the organisms alive that breaks down the waste and is an essential part to the ponds functioning properly.
 - The estimated cost of replacement is \$14,000.

MOVED by Rang and supported by Fleszar to move forward with purchasing a replacement Aeration pump and Check Valve for \$21,500.

B. USDA Loan Application Firetruck – Standish Area Fire Authority

- The Fire Authority will make payments to the city like what the Building Authority does for their loan.
- The loan will be approximately \$330,000.
