- Fleszar Supports Cannabis Retail coming to the city
- Niernberg Spoke to people within the community that does not want to see Cannabis come to the city in anyway.
- Lincoln Individuals she spoke to were against cannabis being within the city limits but expressed fear of repercussions if they came to express their disapproval of the matter.
 - Has heard numerous complaints about the cannabis in AuGres and people it has brought into the community
- Chase Mitrzyk asked council if they inquired with other communities that have Cannabis and how it has impacted them.
- City Manger of AuGres City He has had a lot of complaints from people due to the smell
 - Older generations don't like it due to the stigma it brings with it.
 - o Seasonal workers have caused a lot of complaints in AuGres area
 - o Can cause a negative reputation travelers complain about the smell
 - o Does the city need the revenue?
 - o Cannabis retail will not make the city a tourist hot spot.
- Tom Reif -
 - People in the area are against it due to in part fearing the unknown, education is the key to helping overcome this fear
 - o offered to provide a free class on the topic at the next City Council meeting, it will be approximately an hour long.

- Spencer This was discussed a long time ago and they city already opted out.
 - The vote in the past on the topic was a 6 no to 1 yes vote.
- Fleszar Suggested we table to matter and have Mr. Reif come to the next meeting and provide the council and community with a free informational class.
- Lincoln Expressed that some of the community is fearful of the type of people it will bring to our community.

Mayor King tabled the topic till the next council meeting on March 10, 2025, at 6pm where Mr. Reif will hold an informational class.

9. **NEW BUSINESS**

A. Brush for Sidewalk Tractor

- The brush for the sidewalks is down for repairs, we are currently working with the snowblower.
- Parts to repair the brush will be \$1,500, a new brush is \$3,500
- The City Manager suggested purchasing a new brush and repairing the current brush, so when one is down, we can continue to clean the sidewalks.
- DDA may help with purchasing the new brush.
 - o Currently this is not permitted within the city limits.

MOVED by Link and supported by Lincoln to move forward with repairing the sidewalk brush and to purchase a new sidewalk brush for \$3,500.

B. VFD Water Plant

- There was a power surge at the Water Plant damaging one of our VFDs.
 - o There are currently 5 VFD units at the Water Treatment plant
- To replace one unit will be approximately \$15,000
- Consumers said that they show no issues in our area, indicating a power surge
- This same thing happened approximately 2 years ago, consumers said they had no issues, and our insurance would not cover it unless the cause can be pinpointed
- A surge protection needs to be considered to protect the equipment in this building
- Tribal 2% may fund the purchase surge protection for this building
 - o Mid-March is the deadline to apply for 2% grant Mid-May is when you find out what you are granted
- Surge protection should have been placed on this building as soon as possible, due to the cost of the equipment located in this facility.
- Approximate cost of surge protection being installed in \$30,000

MOVED by Link and supported by Fleszar to purchase the new VFD for \$15,000 and ask for a surge protector during the spring 2% Tribal grant.

C. Dobson Drain – Schedule & Traffic, Box Culvert @ US-23/M-13 @ Mill St.

- There are utilities that run along the culvert
