8. <u>CURRENT BUSINESS</u>

A. Second Reading – Budget 2025-2026

- General funds will see a 3.1% increase from tax revenue this coming fiscal year
- Staffing wages will increase once DPW position is filled in the next few months
- State is making changes to Act 51 funds for road repairs, possibly allowing for more repairs to be completed in the future
- Contract for Trash is out for bids expect a 2-3% increase in the cost of this service

- DDA has a healthy budget funds are utilized to help with the downtown area
- Sewer fund is running at a loss rate study will be completed with the sewer project taking place this year, possible resulting in an increase in sewer rates
- Water funds are healthy and are expected to grow in the coming year with the completion of the water main to Standish-Sterling schools on Grove Rd.
- Final read will be completed at a special meeting on April 28, 2025, at 6pm

B. Wheeler Road Gravel Project

- Received \$57,000 for gravel to be placed on Wheeler Rd. from the Tribal 2% grant.
- Discussion was held about the boundaries of the city and what portion of some roads were considered city responsibility.

MOVED by Link and supported by Lincoln to approve the Road Commission to begin work on Wheeler Road.

A. My Michigan Medical Center Standish – Quick Claim Deed

- The way the description is written for My Michigan Medical Center property on Cedar St. it shows that a 12-foot strip of their parking lot belongs to the city
 - o They are requesting the City complete a Quick Claim Deed for this property over to My Michigan Medical Center
 - My Michigan Medical Center had their attorneys complete all the paperwork/quick deed for this request.
- This was an error made when the description was completed at the time this property was sold, the city should not have this strip of land.

C. United Postal Service – ACH

- UPS is charging \$25 when they are paid via check, the only way to avoid this fee is to have ACH payments set up
- We utilize UPS to ensure our samples from the water treatment plant and sewer plant are sent to the state within 24 hours of the time the sample is taken.
 - This time frame is put in place by the state and each time we must retake a sample it is additional expenses

MOVED by Fleszar and supported by Lincoln to set up ACH payments to the United Postal Service to avoid fees associated with paying with check.
