- Council invited to attend.

10. CITY MANAGER REPORT

City Manager Mason reported:

- School water project awaiting pump house (expected February).
- Sterling Area Health Center opening at the community center; council invited to tour on September 10, 4–8 p.m.
- 307 N. Main St. nearly complete; awaiting final approval from EGLE.
- Dobson Drain box culvert project starting soon (after holidays).
- Spark Grant bid packet submitted; bidding must be completed by Dec. 31, 2025.
- Sewer project: first portion bids received; awaiting second portion.
- Antenna tower approved by Standish Township.

11. MAYOR & FIRE AUTHORITY REPORT

Mayor King reported:

- Sterling Area Fire Authority is considering merging with Standish Area Fire Authority.
- Merger will require approval from all municipalities involved.

12. COUNCIL MEMBER COMMENTS

Lincoln: Asked about substation issues. City must enforce grease trap inspections at restaurants

due to excessive grease in the sewer system.

Myers: Suggested council members have shirts for parades for visibility.
